Georgia AAUW State Convention is coming to Kennesaw, **April 24-25**. Mark your calendars and plan to participate and engage with AAUW friends and colleagues from Georgia and from our national office.



We will have a dynamic speaker and AAUW treasure from the national office come share this time with us: **Lisa Maatz**

As AAUW's top policy adviser, Maatz works to advance AAUW's priority issues on Capitol Hill, in the White House, and in coalition with other organizations. She is a sought-after speaker across the nation and in our nation's capital, and has a large and devoted following on Twitter. Lisa also provides leadership to several coalitions working to advance opportunities for women and girls, including the National Coalition for Women and Girls in Education and the Paycheck Fairness Act Coalition. Recently featured in the book *Secrets of Powerful Women*, Lisa has developed a reputation for her strategic approach to legislation and advocacy. She has done similar work for the NOW Legal Defense and Education Fund and the Older Women's League, and was a legislative aide to U.S. Congresswoman Carolyn Maloney (D-NY). Her grassroots advocacy career began when she was the Executive Director of Turning Point, a battered women's program recognized for excellence by the Ohio Supreme Court. Lisa is a Phi Beta Kappa graduate of Ohio University, and currently serves on the university's Diversity Alumni Advisory Board. She has two master's degrees from Ohio State, and holds an adjunct appointment with the Women and Politics Institute at American University.

At the convention, an agenda will be provided and the registration form is attached to the newsletter, as well as state officer nominee BIOS. The newsletter and registration form will also be posted on the state website.



One Member One Vote:

With the change to a new voting procedure, everyone will receive an individual electronic ballot with the names of nominees for two state officer positions: Co-President, 2015-2017 and Finance Officer, 2015-2017. In addition, the ballot will include a proposed bylaws change to be voted on by the membership. You will receive advance notice about the survey before it goes out. Look for these ballots to come to your e-mail by **March 15th**. Georgia AAUW will use Survey Monkey to submit and receive your ballots. Voting will be anonymous. Instructions for completing your selection will be included as well as an indication of the last date to submit your ballot – **April 10th**.



Georgia AAUW Public Policy Updates

HB 92 is the new version of the **Family Care Act** introduced in the 2015 Georgia General Assembly Legislative Session. AAUW is actively involved with the Georgia Job and Family Collaborative and 9to5 to get this bill passed. The bill is sponsored by District 31 Representative Tommy Benton of Jefferson. The new bill has been enhanced with more detailed definitions and now includes grandparents and grandchildren, as well as parent, child and spouse as immediate family. The bill is a small step forward for working families in Georgia to be able to balance the care of family with work by providing flexible use of sick leave, when it is offered, whether paid or unpaid.

DMST Lobby Day

SB 8 and **SR 7** had immense support on the day the bill and resolution, respectively, were up for a vote in the Senate. On February 12th, at the Freight Depot, over 500 people gathered for a DMST* Lobby Day event sponsored by Georgia Cares, Wellspring Living, Street Grace and Youth Spark. These groups work tirelessly to protect and provide services to children that are victims of sexploitation as well as fighting for tougher laws and penalties for those engaged in victimizing children. AAUW members and other attendees worked the ropes at the capitol to encourage a 'yes' vote from their senators for the bill and the resolution. The bill's sponsor, Senator Rene Unterman, was ecstatic with the 52/3 vote the bill received. *DMST: *Domestic Minor Sex Trafficking*.

HB 194 is a bill proposing changes to early voting parameters and on February 18th, League of Women Voters of Georgia Lobby Day found attendees speaking with representatives and asking them to vote “NO” on the bill when it came up for a vote. It would basically eliminate one full week of early voting. Statistics show that 30-40% of early voting occurs during the first week throughout districts in Georgia.

Atlanta Branch

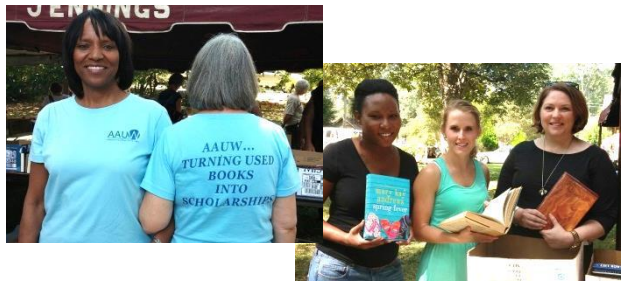

Cartersville-Bartow Branch

The Cartersville-Bartow branch has developed a STEM program in partnership with the Tellus Science Museum. Tellus education director Cantey Smith and AAUW member/STEM chair Tanya Hyman (a middle school science teacher and former local scholarship recipient) have collaborated to create a six-part science experience. On six Wednesdays and Saturdays from January through June, twenty-five middle school girls will come to the Tellus for a talk by a female scientist and a hands-on make-and-take based on one of the galleries of the museum (gems and minerals; motion/transportation; paleontology; planetarium/observatory). Parents will be invited to join a kickoff luncheon for the first event of the series. It's a major undertaking for a small branch, and we hope it will be a success.

We've also worked to move the Family Care Act forward in the Georgia legislature. After a training session with a lobbyist from the Georgia Job/Family Collaborative, three AAUW members and another constituent met with Rep. Paul Battles in December at his local office to make our case for its passage. Although he did not promise to support the bill, it is certainly on his radar now, and he is well aware of its importance to us.

Finally, our book sale, our signature project in the community, again netted enough for us to award three scholarships to non-traditional female students. At our most recent Cobb Branch meeting on February 10th at Sterling Estates found a dynamic duo addressing us about Female Military Veterans transitioning to civilian life. This was presented by one of our members, Dr. Amy Stevens, an advocate who provides a Facebook outreach for GA Military Women - and her colleague, Kim Scofi, with Battle Buddy of United Military Care.org. It certainly was an eye-opening look into the challenges of women serving in the military, especially as they transition back to civilian life. Some of the stories relayed spoke to homelessness, PTSD and mental challenges adjusting to so many changes. Amy shared the heartbreaking story of a Cobb County resident, Kisha Holmes, a female military veteran, who recently killed herself and her children. It was a wakeup call that rang across the local and national news. At this time, Amy and Kim's organizations are looking for individuals to step up and help out in even the smallest way – donating time, donating household goods, donating funds ... anything and everything to support those who have served and/or continue to serve us.

Proposed Changes to Georgia AAUW By-Laws

Article IX. Nominations

Section 1. There shall be a nominating committee of five members, three of whom shall be elected at the annual convention. Two shall be elected by the board of directors at the first board meeting of the fiscal year, one of whom shall be elected to serve as chair of the committee.

Change to: There shall be a nominating committee of three members, two of whom shall be appointed at the annual convention. One shall be appointed by the board of directors at the first board meeting of the fiscal year and serve as chair of the committee.
