**PROPOSED CHANGES TO THE BYLAWS OF THE AMERICAN  
ASSOCIATION OF  
UNIVERSITY WOMEN OF GEORGIA  
TO BE VOTED ON AT THE 2020 STATE CONVENTION**

**Proposed Change 1.**

**ARTICLE VIII. FINANCIAL ADMINISTRATION**

Current reading: **Section 5.** Members joining a branch after January 1 shall pay one-half state dues for the fiscal year. Dues for new members may be accepted at any time.

Proposed Change: Delete the first sentence: "Members joining a branch after January 1 shall pay one-half dues for the fiscal year."

Rational: AAUW has done away with the half-year dues at the national level. Proposed by the treasurer and co-presidents.

**New reading: Section 5. Dues for new members may be accepted at any time.**

**Proposed Change 2.**

**ARTICLE VIII. FINANCIAL ADMINISTRATION**

Current reading: **Section 6.** The annual budget and financial report for the state shall be prepared by the Treasurer and Finance Committee and approved by the Board of Directors no later than October 1.

Proposed Change: Delete "and Finance Committee" and insert "in collaboration with the co-presidents."

Rational: Given declining membership and how challenging it is to get volunteers to serve on committees, do away with the finance committee. Proposed by the treasurer.

**New reading: Section 6. The annual budget and financial report for the state shall be prepared by the Treasurer in collaboration with the co-presidents and approved by the Board of Directors no later than October 1.**

### **Proposed Change 3.**

#### **ARTICLE IX. OFFICERS**

Current reading: **Section 3.** The appointed officers of this organization shall be chairs of Public Policy, AAUW Funds, an historian, a membership chair, a program chair, a parliamentarian, and such other officers as shall be deemed desirable to carry on the work of this organization. These officers shall be appointed by the co-presidents and approved by the executive committee.

Proposed Change: Delete “an historian,” and “a program chair.”

Rational: It has been more than ten years since either of these positions was filled. It is obvious that the positions are not needed. Proposed by the Bylaws Committee.

<p><b>New reading: Section 3. The appointed officers of this organization shall be chairs of Public Policy, AAUW Funds, a membership chair, a parliamentarian, and such other officers as shall be deemed desirable to carry on the work of this organization. These officers shall be appointed by the co-presidents and approved by the executive committee.</b></p>

### **Proposed Change 4.**

#### **ARTICLE XIII. TERM OF OFFICE**

Current reading: **Section 3.** The officers of the state shall take office July 1, except that the incoming co-president may call a meeting of the executive committee-elect for the purpose of approving appointments and making plans for the coming year. Officers shall serve for a term of two years, or until their successors have been elected or appointed and have assumed office. No member shall hold the same office for more than two (2) consecutive terms with the exception of the historian.

Proposed change: Delete “with the exception of the historian.”

Rational: We don't have a historian. Proposed by the Bylaws Committee.

<p><b>New reading: Section 3. The officers of the state shall take office July 1, except that the incoming co-president may call a meeting of the executive committee-elect for the purpose of approving appointments and making plans for the coming year. Officers shall serve for a term of two years, or until their successors have been elected or appointed and have assumed office. No member shall hold the same office for more than two (2) consecutive terms.</b></p>

## **Proposed Change 5.**

### **ARTICLE XIII. TERM OF OFFICE**

Current reading: **Section 4.** A vacancy in any office, except that of the president, occurring in the interim between the annual state conventions, shall be filled by appointment by the executive committee for the unexpired term.

Proposed change: Change “the president” to “a co-president.”

Rational: Normally we would change “the president” to “the co-presidents,” but that isn’t appropriate in the situation. Proposed by the Bylaws Committee.

<p><b>New reading: Section 4. A vacancy in any office, except that of a co-president, occurring in the interim between the annual state conventions, shall be filled by appointment by the executive committee for the unexpired term.</b></p>

## **Proposed Change 6.**

### **ARTICLE XIV. BOARD OF DIRECTORS**

Current Reading: **Section 3.** The board shall recommend to AAUW action to be taken in regard to new branches, admittance of, or discontinuance of present branches. a. Upon recommendation of the state president, the state board of directors shall have the right to approve in writing the application of any group of graduates qualified to form a branch within the state, under AAUW Bylaws.

Proposed change: Replace “president” with “co-presidents.”

Rational: This is an editorial change. But an alternative would be to change “the state president” to “a state co-president.” That would require a vote.

<p><b>New reading: Section 3. The board shall recommend to AAUW action to be taken in regard to new branches, admittance of, or discontinuance of present branches. a. Upon recommendation of the state co-presidents, the state board of directors shall have the right to approve in writing the application of any group of graduates qualified to form a branch within the state, under AAUW Bylaws.</b></p>

## **Proposed Change 7.**

### **ARTICLE XIV. BOARD OF DIRECTORS**

Current reading: **Section 5.** Special meetings may be called by the president and shall be called upon written request of five (5) members of the board, provided that at least five days' notice of such meeting and its agenda shall have been given to members of the board.

Proposed change: Change "the president" to "a co-president."

Rational: If a call meeting is necessary and one of the co-presidents isn't available, this would make it possible for the other co-president to call a meeting. Proposed by the Bylaws Committee.

**New reading: Section 5. Special meetings may be called by a co-president and shall be called upon written request of five (5) members of the board, provided that at least five days' notice of such meeting and its agenda shall have been given to members of the board.**

## **Proposed Change 8.**

### **ARTICLE XIV. BOARD OF DIRECTORS**

Current reading: **Section 7.** Between meetings of the state board, a written vote may be taken at the request of the president on any question submitted in writing. Voting shall close fifteen days after the question has been submitted. If a majority shall vote on a question sent to the members of the board, the vote shall be counted and shall have the same effect as if cast at a meeting of the board.

Proposed change: Change "the president" to "a co-president."

Rational: If a written vote is necessary and one of the co-presidents isn't available, this would make it possible for the other co-president to call for a written vote. Proposed by the Bylaws Committee.

**New reading: Section 7. Between meetings of the state board, a written vote may be taken at the request of a co-president on any question submitted in writing. Voting shall close fifteen days after the question has been submitted. If a majority shall vote on a question sent to the members of the board, the vote shall be counted and shall have the same effect as if cast at a meeting of the board.**



### **Proposed Change 9.**

#### **ARTICLE XV. EXECUTIVE COMMITTEE**

Current Reading: **Section 3.** The executive committee shall meet at the call of the president or at the written request of one-half of its members.

Proposed change: Change “the president” to “a co-president.”

Rational: If a call meeting is necessary and one of the co-presidents isn’t available, this would make it possible for the other co-president to call a meeting. Proposed by the Bylaws Committee.

**New Reading: Section 3. The executive committee shall meet at the call of a co-president or at the written request of one-half of its members.**

### **Proposed Change 10.**

#### **ARTICLE XV. EXECUTIVE COMMITTEE**

Current Reading: **Section 6.** Between meetings of the executive committee, a written vote may be taken at the request of the president on any question in writing. Voting shall close ten days after the question has been submitted. If a majority shall vote on a question sent to the members of the executive committee, the vote shall be counted and shall have the same effect as if cast at a meeting of the executive committee.

Proposed change: Change “the president” to “a co-president.”

Rational: If a written vote is necessary and one of the co-presidents isn’t available, this would make it possible for the other co-president to call for a written vote. Proposed by the Bylaws Committee.

**New Reading: Section 6. Between meetings of the executive committee, a written vote may be taken at the request of a co-president on any question in writing. Voting shall close ten days after the question has been submitted. If a majority shall vote on a question sent to the members of the executive committee, the vote shall be counted and shall have the same effect as if cast at a meeting of the executive committee.**

### **Proposed Change 11.**

#### **ARTICLE XVI. COMMITTEES AND TASK FORCES**

Current reading: **Section 1.** Standing committees shall be program development, membership, public policy, finance, AAUW funds, college/university relations, bylaws, and communications.

Proposed change: Delete “program development” and “finance.”

Rational: We have not had a program development committee for a long time. It’s not needed. Proposed by the Bylaws Committee. The finance committee is not necessary because the treasurer and co-presidents can accomplish the task. Proposed by the Treasurer.

<b>New reading: Section 1. Standing committees shall be membership, public policy, AAUW funds, college/university relations, bylaws, and communications.</b>

### **Proposed Change 12.**

#### **ARTICLE XVI. COMMITTEES AND TASK FORCES**

Current reading: **Section 4.** Special committees may be appointed by the president with the consent of the board of directors.

Proposed change: Change “president” to “co-presidents.”

Rational: This is an editorial change and doesn’t require a vote.

<b>New reading: Section 4. Special committees may be appointed by the co-presidents with the consent of the board of directors.</b>

### **Proposed Change 13.**

#### **ARTICLE XVII. MEETINGS OF THE STATE**

Current reading: **Section 3.** Special meetings may be called by the president. Or shall be called by the president on the written request of one-third of the members of the board of directors.

Proposed change: “Special meetings may be called by the president” becomes “Special meetings may be called by the co-presidents.” “Or shall be called by the president” becomes “shall be called by a co-president.”

Rational: A call meeting of the state should be a decision of both co-presidents unless it has been requested by one-third of the members of the board, in which case either co-president can call the meeting. Proposed by the Bylaws Committee.

<p><b>New reading: Section 3. Special meetings may be called by the co-presidents, or shall be called by a co-president on the written request of one-third of the members of the board of directors.</b></p>
